

MATCHING POLICE LETTER AND DEATH THREAT NOT INVESTIGATED

Just as important as what was investigated in this case is what was not investigated. The FBI seemed to go out of their way to avoid following leads that could incriminate anyone other than environmentalists. This is particularly important because some of these leads appear to implicate the big timber companies and police in the campaign of harassment that surrounded the bombing.

The most important of these leads concerns one of the written death threats I received right before the bombing. Through our own investigation, we discovered that this threat was typed on the same typewriter and in a matching style to an anonymous letter sent to local police by an informant 1½ years before the bombing, unknown to me at the time.

This letter reported on my political activities, distorting information to make me look like a terrorist. Because of the specific information contained in this letter, I am certain I know who wrote it -- a man named Irv Sutley. Based on these suspicions, we have located the actual typewriter on which the documents appear to have been typed, in an office where Irv Sutley worked. But since the FBI possesses the original document, we cannot establish a forensic link without their cooperation.

Irv Sutley has a long history of disrupting activists in Northern California, and I suspect he works for the FBI. This suspicion is enhanced by the FBI's reaction to the information we supplied about him. We have publicly hand the two matching letters to the FBI and asked them to investigate them. In addition, the Willits Police have examined these two letters on their own document analysis machine and also determined that they appear to match. The Willits Police turned the matching documents over to the FBI and have records of having done so. They also told the FBI of my suspicions of Irv Sutley being the author. They are willing to talk to the Congressional Committee about this.

The FBI assured the Willits Police that they would investigate the matching documents. However, in the entire 5,000 pages of FBI files, the documents do not appear at all. There is no mention of them or of Irv Sutley. And the FBI's descriptions of their conversations with the Willits Police omit any reference to Sutley or the documents, even though this was a principal subject of the conversation.

It is particularly significant that the FBI failed to investigate the police informant letter because it was accompanied by a photograph of me holding an Uzi submachine gun. This photograph was distributed to the press by timber interests and police after the bombing in an attempt to make me look like a terrorist. In fact, the Uzi is owned by Irv Sutley, and he posed me with it for what I thought was a gag photo. But if the FBI actually believed I was a terrorist as they claimed, you would think they would have interviewed the police about the source of that photograph. Their failure to do so increases my suspicions.

Note that DNA evidence examined by expert Edward T. Blake in July 2001 confirms that the police informant letter and the death threat letter were sealed by the same male person, and that person's DNA is similar enough to Irv Sutley's that he may be Sutley's father or son. Sutley's father died in Mill Valley CA in December 1998.

Blake also found that an unidentified female licked the envelope and stamp of the "Lord's Avenger" letter taking credit for bombing Judi Bari and accurately describing the bomb components.

Dear Chief Keplinger:

I joined Earth First to be able to report illegal activities of that organization. Now I want to establish a contact to provide information to authorities.

The leader and main force of Earth First in Ukiah is Judi Bari. She is facing a trespassing charge in connection with the Earth First sabotage of a logging road in the Catto Peak area. She did jail time in Sonoma County for blocking the federal building to support the Communist government in Nicaragua.

Bari and the Ukiah Earth First are planning vandalism directed at Congressman Doug Bosco to protest offshore oil drilling.

Earth First recently began automatic weapons training.

Bari sells marijuana to finance Earth First activities. She sometimes receives and sends marijuana by U.S. mail. On December 23 she mailed a box of marijuana at the Ukiah post office.

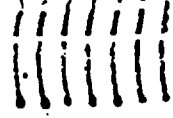
There is no point in pursuing local charges. But the use of the U.S. mail means serious federal charges. If you would like to receive confidential information on short notice to make possible an arrest on federal charges at a U.S. post office next time she mails dope, please do the following:

Place an advertisement in the "Notices" section of the classified ad section of the Ukiah Daily Journal. It should be addressed to "Dear A" and give the name and telephone number(s), preferably 24-hour, of a detective who should be called to receive this information.

When a call is made, I will identify myself as "Argus"

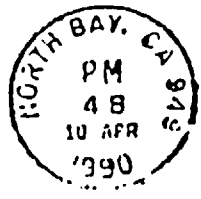

I built with these hands the bomb that I placed in the car of Judi Bari. Doubt me not for I will tell you the design and materials such as only I will know. I come forward now emboldened by the Spirit of the Lord to spread the Message spoken by the bomb so that All will hear it and take it into their Hearts. This woman is possessed of the Devil. No natural woman created of our Lord spews forth the Lies, Calumnies and Poisons that she does with such Evil Power. The Lord cleared my Vision and revealed this unto me outside the Baby-Killing Clinic when Judi Bari smote with Satan's words the humble and Faithful servants of the Lord who had come there to make witness against Abortion. I saw Satans flames shoot forth from her mouth her eyes and ears proving forever that this was no Godly Woman no Ruth full of obedience to procreate and multiply the children of Adam throughout the world as is God's Divine Will.

Let the woman learn in silence with all subjection. But I suffer not a woman to teach, nor to usurp authority over the man, but to be in silence.

Timothy 2:11

She and her blasphemous host try to abort the children of Adam and erase us from the Face of the Earth which was Created by God to be our Home so that we will fill it with our Numbers in His Name. She spoke Satan's Words yet the Lord did not strike her Down. Darkness fell upon my Spirit. My prayers sought Guidance so I would know if the Lord was calling me to Wield His W Sword. I could hear no Answer but Satan marched on and caused great Uproar over the land. I was Weak and my Faith in the Lord's Power was lacking. I dared not Strike at the demon herself. No, instead the Devil moved my hand to bomb in Cloverdale to bring Infamy down on Judi Bari. The bomb was 1½ inch galvanized pipe with galvanized end caps candle wax on threads. One cap drilled so wires could go to the igniter match heads inside a model paint bottle to be set off by flashlight filament. Epoxy glue in the drill hole. The pipe was Set in a plywood box with a One gallon gas can filled with 70:30 mixture gas & oil. On top of the box was timer-pocket watch with minute hand gone and small hex head screw drilled into the lense. Battery was 9 Volt. A Light switch for safety and light socket for Test lamp. And the bomb was placed and the hour hand touched the Screw and the bomb exploded. But the Almighty Lord took Pity on my Foolishness and a Miracle came Forth. The gas oil mixture did not explode! Praise God! With this Sign the Lord told me Use not Indirection. The Lord had shown me that his Work needed no Subtergufe and must be clear and Visible in the eyes of a ll. I was His Avenger. The demon must be struck down. The Light filled me and my Faith was impregnable. Great joy Filled me I set to work.

I put the bomb in her car whilst she was at the meeting with the loggers. The wicked shall know no Refuge. It was 2 inch galvanized pipe 11 inches long with black iron end Caps one drilled for wires to go to the matchhead Igniter Bottle. Epoxy glue in the drill hole. Explosive 3:1 potassium chlorate:aluminum powder. 3 sizes of finishing nails taped on the Outside and pipe taped to a piece of paneling that fit under her seat and the paneling had the pocket watch and also a motion switch of 2 bent wires and a ball. 9 volt battery again and safety switch and Test socket empty. Ticking of the watch was Silenced by a piece of yellow sponge and the whole Device covered with blue towel. The wires were red and black and well Soldered to the Battery. And the Bomb was Hidden and the hour hand Moved. But it did not Explode! The Lord had Made another Miracle. He had stopped the hand of the watch by His Divine Intervention. I was seized by Doubt and Confusion but my Faith told me that a Higher Purpose must be at Work. For two nights and two days the hand was stayed until the Demon was joined in her car by the VERY SAME man who had helped her Mock and Insult the Faithful outside the Abortion Clinic that day years ago. 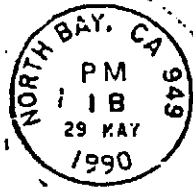
